- 2. Information on how to participate and the offer are part of these Terms and Conditions.

Participation

The promotion is open to individual Australian residents "Participants".

Purchase Period

 The purchase period commences at 9:00am (AEDT) 13 November 2014 and closes at 11:59pm (AEDT) 30 January 2015 ("Purchase Period").

Eligible Purchases and Cashbacks

- Where a Participant makes an "Eligible Purchase" they can submit a claim for a cashback in accordance with clauses 7 and 13
- 6. An "Eligible Purchase" is a Participant's purchase of any new (not pre-owned) Eligible Product listed in clause 7 during the Purchase Period from Canon Australia's online store or from an authorised Canon Australia retailer in the Canon Australia Distribution Channel.

Double Cashback

8. Subject to clauses 9 and 10, if at the time of making an Eligible Purchase, a Participant also spends at least an additional \$200 (including GST) or more on other Canon product/s in the same transaction with a single receipt, the Participant will instead be eligible to submit a claim for double the amount of the applicable Cashback listed in clause 7 ("Double Cashback").

One cashback per transaction

 Only one cashback (whether it is the Cashback or the Double Cashback) may be claimed per transaction. Receipts cannot be combined to claim cashbacks.

Purchasing multiple Eligible Products

- Where two or more Eligible Products are purchased in the same transaction, the Cashback or Double Cashback (as the case may be) will be applied to the Eligible Product with the highest cost.
- 11. Participants can submit more than one claim provided that each claim is made on the basis of a separate transaction with a separate receipt, and is otherwise made in accordance with these Terms and Conditions.

Maximum cashback

 For the avoidance of doubt, the maximum cashback that a Participant can potentially claim for any single transaction under this promotion is \$400 (being a Double cashback).

How to claim cashbacks and deadline for claiming cashbacks

- 13. Claims submission methods:
 - All Participants must:
 - (i) visit canon.com.au/doublecashback, login to MyCanon or sign up for a MyCanon account, input their details including full name, valid email address, bank account details (to receive an EFT transfer) OR postal address (to receive a cheque), and submit the claim by 11:59pm (AEDT) 27 February 2015; and
 - (ii) upload a copy of their receipt OR mail a copy of the receipt together with a printed copy of the claim form to "Canon Cashback, PO Box 706, Eastern Suburbs MC, NSW 2004" in time to be received by last mail on 27 March 2015.



- 14. Failure to produce a receipt will result in the forfeiture of any right to a cash back.
- No responsibility will be accepted by the Promoter for late or misdirected claims.

Payments

- 16. The cashback will be paid to the Participant named on the valid claim form submitted to the Promoter in accordance with these Terms and Conditions. Claims will be paid within 30 days of the Promoter verifying the claim by sending a non-negotiable cheque or carrying out an electronic funds transfer (EFT).
- 17. It is the responsibility of the Participant to provide correct details. Delays and non-payment of claims that arise as a result of supplying incorrect details are the responsibility of the Participant. Cash backs are not transferable or assignable.
- 18. Any bank transaction fees associated with the clearance of funds, or any other costs associated with accessing the promotional website, scanning or copying receipts, or otherwise submitting a claim is the responsibility of the Participant.

Staff of the Promoter

 This promotion is not available in conjunction with any staff discounts available to officers and employees of the Promoter.

Collection of personal information

Interpretation

- 23. Canon Australia's network of authorised distributors, dealers and retailers form the "Canon Australia Distribution Channel". See www.canon.com.au/en-AU/Personal/Support-Help/ Dealer-Service-Locator to find authorised retailers.
- 24. Canon-branded products that have been sourced by endusers, distributors or retailers from any source other than through Canon Australia's official online store or from an authorised Canon Australia retailer in the Canon Australia Distribution Channel (including 'grey', 'parallel' or 'direct' imports) are not Canon Australia products and do not constitute Eligible Purchases.

Other conditions that may invalidate a claim

- 25. The Promoter reserves the right, at any time, to verify the eligibility of Participants and the validity of a claim (including contacting the place of purchase), and to invalidate any claim that is not in accordance with these Terms and Conditions, or to disqualify any Participant who tampers with the claim process.
- 26. Incomplete or illegible claims may be deemed invalid, although errors and omissions may be accepted at the Promoter's discretion.
- 27. Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of those rights.
- 28. If this promotion is interfered with in any way or is not capable of being conducted as reasonably anticipated due to any reason beyond the reasonable control of the Promoter, the Promoter reserves the right, in its sole discretion, to the fullest extent permitted by law (a) to disqualify any Participant; or (b) to modify, suspend, terminate or cancel the promotion, as appropriate.

Except for any liability that cannot by law be excluded, including the Non-Excludable Guarantees, the Promoter (including its respective officers, employees and agents) is not responsible for and excludes all liability (including negligence) for any personal injury or any loss or damage (including loss of opportunity) whether direct, indirect, special or consequential arising in any way out of the promotion, including (without limitation): (a) any technical difficulties or equipment malfunction (whether or not under the Promoter's control); (b) any theft, unauthorised access or third party interference; (c) any claim that is late, lost, altered or misdirected (whether or not after their receipt by the Promoter) due to any reason beyond the reasonable control of the Promoter; (d) any tax liability incurred by an Eliqible Claimant; or (e) use of the cash back.
